FULL OR ASSOCIATE MEMBERSHIP

There is no difference between Full and Associate Membership except that while there is no limit to the number of Full Members, the total of Associate Members may not exceed 25% of the total membership.

FULL MEMBERSHIP is offered to British nationals and the wives and widows of British nationals i.e. those who hold a British passport or whose husbands (or late husbands) do (did) so. This includes holders of passports issued by British Dependent Territories (e.g. Bermuda).

If you believe you may be entitled to a British passport but do not have one, we suggest you check your status first with the British High Commission, 19 St Clair Avenue, Port of Spain.

ASSOCIATE MEMBERSHIP is a category created primarily for other expatriates who do not have a club of their own. Once accepted you will be a member on equal standing with Full Members, with the exception that you are unable to stand for the position of President or Vice President.

In either case, your completed form will go to the Management Committee for acceptance. They will contact you and invite you to the next monthly meeting or welcoming coffee morning. You should pay your subscription then.

The full subscription is payable annually in March. Anyone joining after August may pay a reduced subscription fee. A one-off joining fee is also payable. If we do not receive your subscription and joining fee within two months of your acceptance, we will disregard your application unless you let us know the reason for not paying.

ENTRANCE FEE AND MEMBERSHIP DUES The entrance fee is TT\$200, which includes Year Book and Constitution, plus TT\$150 annual membership if under 60 or \$75 if 60 or over, making a first payment of TT\$350 or TT\$275 depending on age, for both full and associate members. The annual membership subscription of TT\$150 (under 60) or TT\$75 (60 or over) for both full and associate members is due to the Treasurer at or before the Annual General Meeting in March each year. Any applicant who has been accepted as a member in September, October or November shall pay an entrance fee and only half (i.e TT\$75 (under 60) or TT\$37.50 (60 or over) of the annual membership subscription. Any applicant accepted as a member in December, January or February shall pay an entrance fee and the full annual membership subscription for the ensuing year.
